



Terms and Conditions

Please read the following terms and conditions carefully before enrolling in the Loose Leash Walking Group Class ("the Class"). These terms and conditions outline the agreement between you (the "Participant") and Leader Of The Pack ("the training organization" or "we" or "us"). By enrolling in the Class, you acknowledge and agree to comply with the following terms and conditions:

1. Class Description:
 - a. The Class is designed to provide training and guidance to help Participants teach their dogs loose leash walking skills and drills.
 - b. The Class will consist of a series of group sessions conducted by a professional dog trainer.
2. Participant Responsibilities:
 - a. Participants must ensure that their dog is up-to-date on all required vaccinations and in good health and physical condition.
 - b. Participants must handle their dogs responsibly and maintain control of them at all times during the Class.
 - c. Participants must comply with all instructions and guidelines provided by the trainer and follow positive reinforcement-based training methods.
3. Liability:
 - a. Participants understand that dogs may exhibit unpredictable behaviors, and while every precaution will be taken to ensure safety, participation in the Class is at the Participant's own risk.
 - b. Participants agree to assume all responsibility for any injuries, damages, or losses incurred as a result of their actions or their dog's behavior during the Class.
 - c. Participants are responsible for any damages caused by their dog to property, other dogs, or individuals attending the Class.
 - d. Participants agree and understand that this is not a behavior modification class and that they may be asked to leave or be moved away from the group if their dog is aggressive, reactive, or disruptive to the class.

- e. Participants agree and understand that they cannot switch out dogs and that the dog that is originally registered for group training is the dog that must attend each class.
4. Cancellations, Transfers, and Refunds:
 - a. Participants must provide a minimum of 1 week's notice if they wish to cancel their enrollment in the Class. A full refund will be issued if the cancellation notice is received within this timeframe.
 - b. Cancellation requests received less than a week before the class will be refunded half of the class fee.
 - c. Cancellation requests received less than 48 hours before the Class or failure to attend without prior notice will not be eligible for a refund.
 - d. Participants understand that the class is non-transferable to any other service or product.
 5. Intellectual Property:
 - a. All training materials, handouts, and resources provided during the Class are the intellectual property of the training organization and may not be reproduced, distributed, or shared without explicit permission.
 6. Class Changes or Cancellations:
 - a. The training organization reserves the right to modify or cancel the Class due to unforeseen circumstances or insufficient enrollment. In such cases, Participants will be notified promptly, and any fees paid will be refunded in full.
 7. Confidentiality:
 - a. Participants agree to maintain the confidentiality of any personal information or training practices shared by other Participants during the Class.
 8. Photography and Video:
 - a. Participants acknowledge that the training organization may take photographs or videos during the Class for promotional and training purposes. By enrolling in the Class, Participants grant the training organization the right to use such media without compensation.
 9. Governing Law:
 - a. These terms and conditions shall be governed by and interpreted in accordance with the laws of Nevada. Any disputes arising from or in connection with the Class shall be subject to the exclusive jurisdiction of the courts of Nevada.
